Turn left to merge onto I-71 S/I-75 S toward I-275/Lexington/Louisville. Take exit 185 to merge onto I-275 E. Take exit 77 for KY-9/Kentucky Aa toward Wilder/Maysville. Keep right at the fork, follow signs for County Rd Aa/KY-9/Alexandria/Maysville and merge onto KY-9 S/Licking Pike. Turn right onto Town Dr. Take the 1st left onto Gloria Terrell Dr. Take the 1st right onto Beacon Dr. Destination will be on the right.
