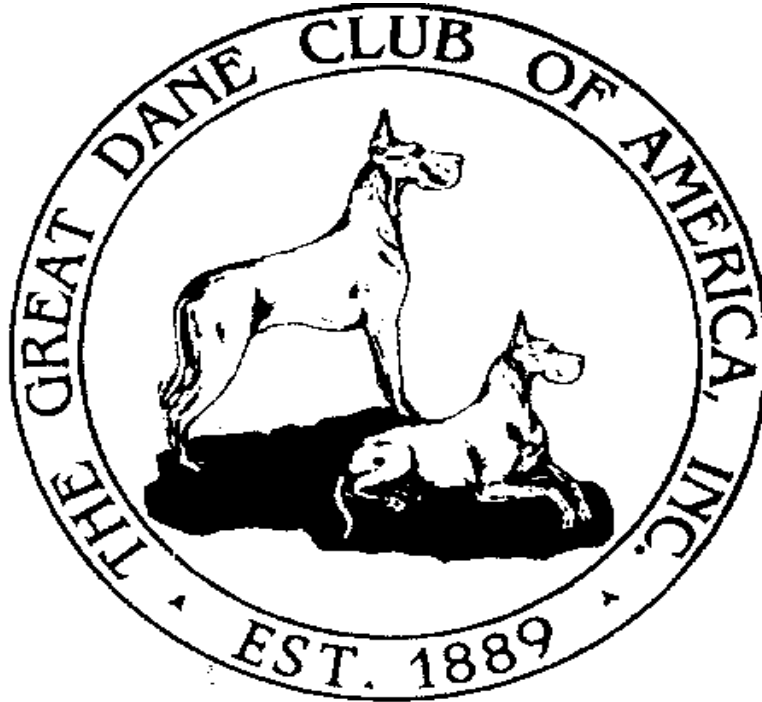

**From the East Valley:** Take I-10 West (past 101 Loop interchange) to the Litchfield Road exit. Turn right (north) on Litchfield Road to Wigwam Boulevard. Turn right on Wigwam Boulevard and proceed past the roundabout - turn left at the roundabout if The Golf Club or Red Allen's is your final destination. The Wigwam hotel entrance will be on your left on Wigwam Boulevard just as you past the elementary school. Self parking is on the right after you enter the main gates, or you are invited to valet park at the arrival court.

**From North Scottsdale:** Take Loop 101 West (towards stadiums, not the airport) to Camelback Road, exit 5. Turn right (west) on Camelback Road approximately 5 miles to Litchfield Road and turn left. Take Litchfield Road to Wigwam Boulevard (approximately a mile). Turn left on Wigwam Boulevard and proceed past the roundabout - turn left at the roundabout if The Golf Club or Red Allen's is your final destination. The Wigwam hotel entrance will be on your left on Wigwam Boulevard just as you past the elementary school. Self parking is on the right after you enter the main gates, or you are invited to valet park at the arrival court.

**From West Valley & Los Angeles:** Take I-10 East to the Litchfield Road exit. Turn left (north) on Litchfield Road to Wigwam Boulevard. Turn right on Wigwam Boulevard and proceed past the roundabout -turn left at the roundabout if The Golf Club or Red Allen's is your final destination.
