DIRECTIONS

From Northeast, Midwest or Northwest. Take I-75 south in Cincinnati then cross the Ohio River. Drive 7 miles to Exit 186 (Buttermilk Pike), turn left upon exiting the interstate. Turn left at second light (Royal Drive).

From Southeast. Take I-75 north in Lexington, KY, travel 75 miles to Exit 186, turn right upon exiting the interstate. Turn left at first light (Royal Drive).

From Deep South, West, Southwest or California. Take I-71 north in Louisville, KY. I-71 joins I-75 at Walton KY. Travel 15 miles to Exit 186 and follow Southeast directions above.

NOTICE !!! - Avoid traveling thru Louisville from the North or West. The I-64 bridge is closed with traffic being re-routed onto the I-65 bridge. Delays will be extremely long!
