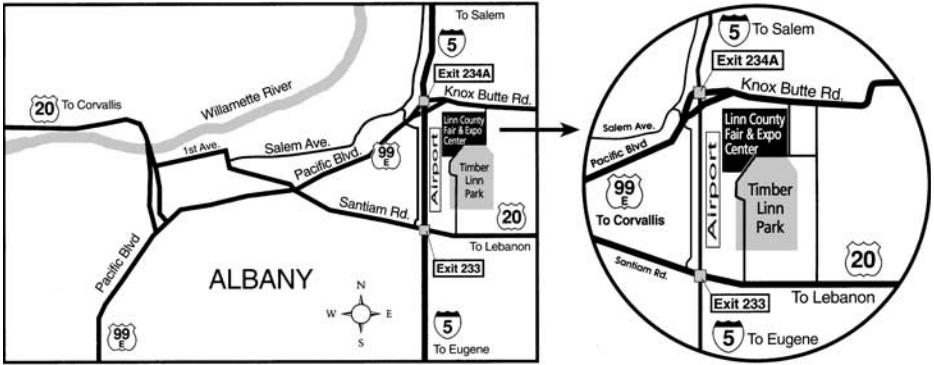

Rivers Edge Pet Medical Center is approximately 3.8 miles from the Linn County Expo & Fair. Head north on Expo Pkwy NE toward Knox Butte Road E. Turn left onto Knox Butte Rd E. Turn right onto Albany Ave SE. Turn left onto SE Salem Avenue. At the traffic circle, take the 1st exit onto SE Main Street. Turn left onto SE 1st Avenue. Turn right onto N Lyon Street. Turn Right onto NW Springhill Drive then turn left onto NW Hickory Street. Rivers Edge Medical Center is in the center on the left. "Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations."
