**USE 11TH AVE**

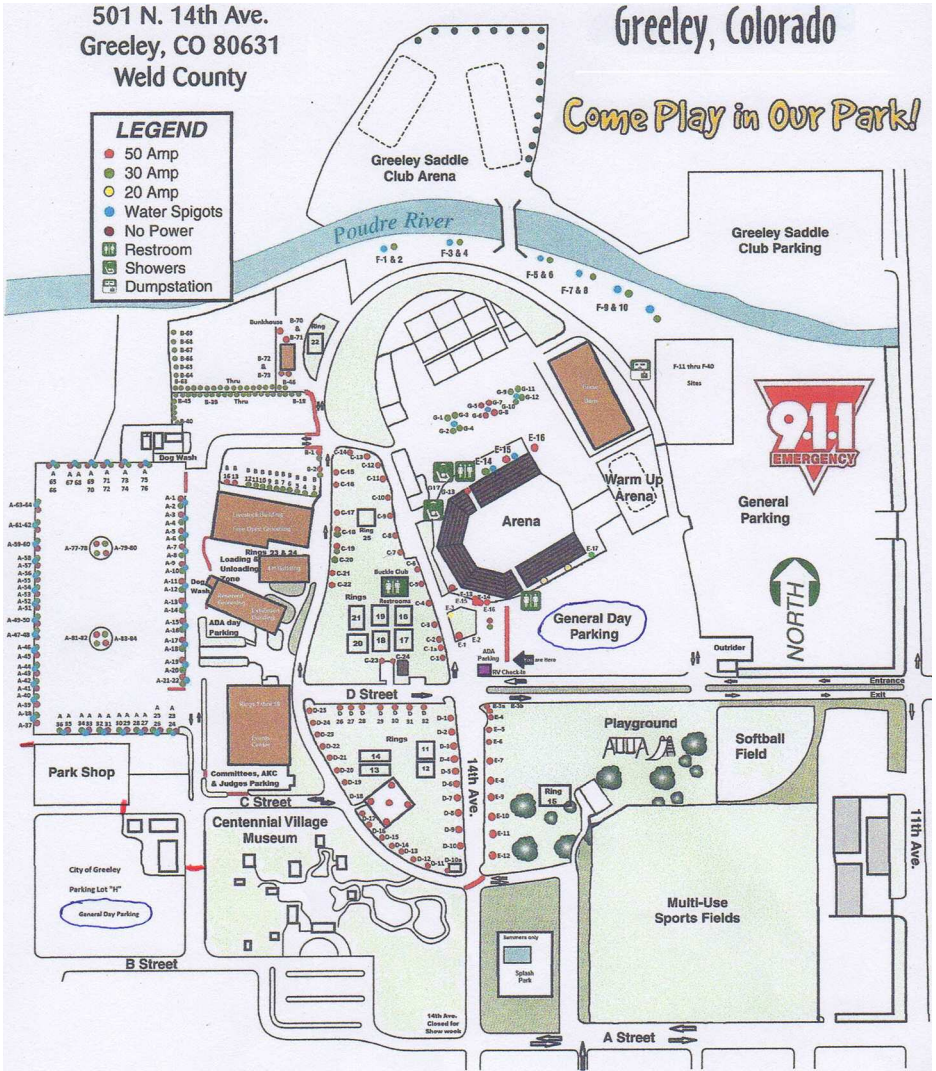
**FROM THE NORTH** - From Hwy 85 take the 11th Ave exit. Proceed South to park entrance.
