PRA Eye Exams & Testing University of Missouri DNA Blood Bank Wednesday, August 20 through Saturday, August 23

Dr. Keiko Miyadera, a veterinary ophthalmologist and genetic researcher, is offering a complimentary eye exam and PRA genetic testing in collaboration with the ESS Foundation and AKC-CHF. Springers of particular interest are:

- Affected dogs and related dogs (e.g., littermate) for repeat or new exams.
- New dogs not DNA tested but have the chance of being Affected.
- Any dog with eye/vision concerns.

("Affected" here means genetically affected, having two copies of a variant in the gene RPGRIP1.)

Please bring your dog's pedigree and study form to participate in the PRA study. Here is a <u>link</u> to the current study form.
