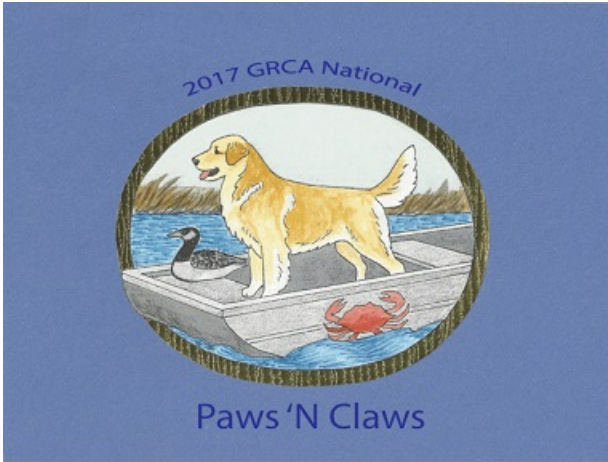

DRIVING DIRECTIONS TO THE SHOW GROUNDS at the Civic Center.

From the north - From I-95 at Philadelphia, take Route 1 South. Follow exit 4A toward DE-1 S/Christiana Mall Road. Merge onto DE-1 S/US-13S, and continue south towards Dover, DE. Exit at U.S. Route 13 South to Salisbury. After entering Salisbury, follow U.S. Route 13 South through Salisbury. Turn left onto E. Main S. Turn right onto Civic Ave and follow to the stop sign. Venue is directly across the street. Travel time: approximately 2 1/2 hours from Philadelphia, PA.

From Points South - Take U.S. Route 13 North from Virginia Beach. When entering Salisbury, take the Rt. 13 By-pass. Next take U.S. Route 50 Business west exit towards Salisbury. Continue west on Rt. 50 to the stop light at Civic Avenue. (Burger King on left.) Turn left onto Civic Avenue and follow to the end of the street at a stop sign. Venue is directly across the street. Travel time: approximately 2 hours from the Chesapeake Bay Bridge Tunnel.

From Points West - Baltimore/Washington D.C. area. Take U.S. Route 50 East from the Chesapeake Bay Bridge in Annapolis, MD. Continue east on U.S. Route 50; stay to the right at the Route 301/50 split. When entering Salisbury continue on Rt. 50 east (business route) and proceed through the downtown area. Turn right at stop light onto Civic Avenue (Burger King on your right) and follow to the end of the street at a stop sign. Venue is directly across the street. Travel time: approximately 1.5 hours from Chesapeake Bay Bridge.
