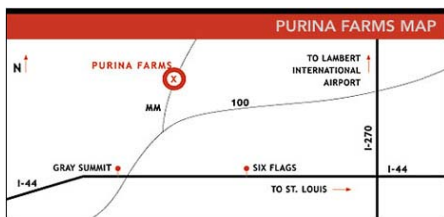

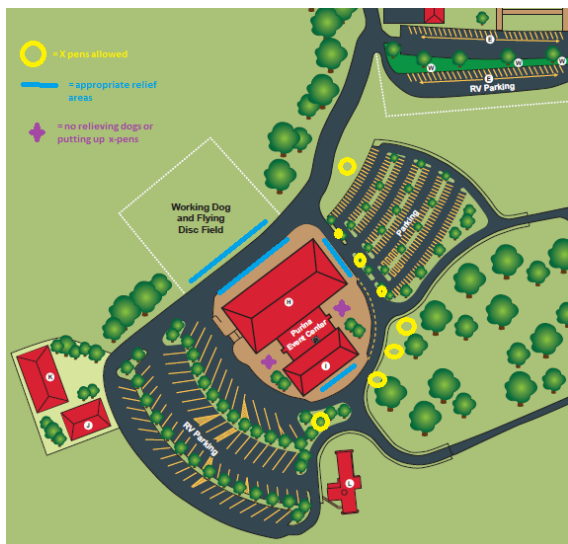


Routes to the Show
