Directions to the Host Hotel/Show Site

Westin Lombard Yorktown Center, 70 Yorktown Shopping Center, Lombard, IL 60148

North: Travel south on Route 53 until it becomes 290 East, then merge on Interstate 355. Continue south on the left towards Joliet and take Butterfield Road (Route 56). Travel toward Aurora and turn left onto Butterfield Road (Route 56), then take a left into Yorktown Shopping Center. Follow the center around to the hotel entrance.

West: Travel onto Interstate 88 east and exit onto Highland Avenue. Turn left onto Highland Avenue after the tollbooth, merging to the far right. Then merge right onto Route 56 east and then take a left into the Yorktown Shopping Center. Follow the center around to the hotel parking lot.

East: From 290 (Eisenhower Expressway) stay in left 2 lanes and continue onto Interstate 88 West. Continue to the tollbooth and exit on Highland Avenue. Taking Chiropractic College, turn right onto Highland Avenue and merge onto Route 56 (Butterfield). Turn into the Yorktown Shopping Center and the route within the parking lot to the hotel.

South: Travel North onto Route 83 then turn left onto 22nd Street. Take 22nd Street until it turns into Butterfield Road. Turn right into Yorktown Shopping Center and follow center around to the hotel entrance.

!! ATTENTION EXHIBITORS !!

All dogs must wear belly bands or britches when on the floor of the hotel lobby, in the hallways, or in the meeting rooms.

Multiple failures to comply will indicate the need for a bench committee hearing.

Grooming will be conducted in the designated grooming areas *only*. Please clean up after yourself and your dog(s).

All crates must be stacked in the grooming areas.

No crates, grooming tables, or ringside tables will be permitted in the Grand Ballroom during judging, except for grooming tables in the reserved ringside grooming area. **Dog strollers (but not for grooming)** will be permitted in the Grand Ballroom, space permitting. **Absolutely NO grooming is permitted in the Grand Ballroom except in reserved ringside grooming area, where no hair dryers are permitted.**

Exercise Pens will be permitted outside only, and in designated areas only, and **MUST** be tagged with owner's name and contact telephone number. Exercise areas will be clearly marked and **ENFORCED**. PLEASE CLEAN UP AFTER YOUR DOG.

Dogs entered at these events MUST have rabies and vaccination records available.

All trophies not claimed on each day of the shows become the property of The Havanese Club of America, Inc. None will be mailed.

No dogs permitted in public restrooms.

An Event Committee Hearing will result from a violation of Hotel Rules or any damage to Hotel/ Motel rooms, grounds or premises. A Bench Committee Hearing will also result in any behavior that is deemed detrimental to the breed or to AKC.

The Hotel requires that dogs be crated in room when owner is not present, and that if you have dogs that persistently bark in the Hotel room, you may be asked to leave the Hotel.
